

Dear Parents,

Thank you for choosing Camp Country Day for 2020. We recognize these are challenging times, but also recognize the need for in-person socialization and for some of you, a safe place for your children to be while you are at work. Our staff is working very hard to create routines and protocols that will keep everyone as safe as possible. These include the following:

- Staff will wear masks indoors, but are not required to do so outdoors. Campers are not required to wear masks but it is permitted.
- Social distancing will be enforced except between siblings and friends who arrive together. [REDACTED]
- Drop off and pick up will be curbside only. Parents may get out of the car to help children but must remain by the car. [REDACTED]
- Temperatures will be taken before anyone (camper or staff) can enter the building. **Anyone with a temperature of 100+ must stay home and may not return until they are fever free for 24 hours, without the use of fever-reducing medication.** If the individual has had contact with someone confirmed or probable to have COVID-19, he or she must complete isolation or quarantine procedures in coordination with the local health department prior to returning to the program. - Anyone with a temperature of 99+ will be rechecked at noon. [REDACTED]
- if your child exhibits **any** of the following symptoms, they must remain at home: cough, shortness of breath or difficulty breathing, fever, chills, muscle pain, sore throat, and new loss of taste or smell. [REDACTED]
- Early Learning campers will enter and exit through the EL door and will remain in that area throughout the day.
- EL campers will have their own designated space to keep belongings. They will have an assigned cot if they are staying all day, and will keep naptime items on their cot. Cots will be sanitized with approved disinfectant daily.
- EL campers will be provided with a daily snack but must bring their own lunch according to the following rules: no nuts, no sugary drinks, and no microwave will be available. [REDACTED]
- Lower School campers will enter and exit through the main doors.
- LS campers will each have an assigned desk in the gym. This will be their personal space throughout the week, including for snack (provided) and lunch which you must provide, according to the following rules: no nuts, no sugary drinks, and no microwave or refrigerator will be available. Siblings or friends who come together can have their desks grouped. [REDACTED]
- All campers who arrive before 9:00 or stay after 3:15 should bring items to keep themselves occupied. They will not be able to play with other campers (except for siblings or friends who arrive together). Electronics will be allowed during this time. [REDACTED]

- If there are two LS groups we will split the gym by pulling the curtain, and will provide separate gym entrances and bathrooms for each group.
- Bathroom surfaces will be sprayed with an approved disinfectant daily and bathrooms will be cleaned by the cleaning crew every Monday before a new group arrives.
- Camp will be held outdoors as much as possible. Our air conditioning system is double filtered for maximum protection.
- Water play will be sprinklers only, with one sprinkler available for each group. Lower School will not go to the creek due to staffing and bathroom limitations. Should restrictions change and allow us to go, we will let you know.

We will do everything in our power to keep your children safe, and appreciate your support in educating them about the requirements and their importance. If you have questions or concerns, please feel free to contact us.
